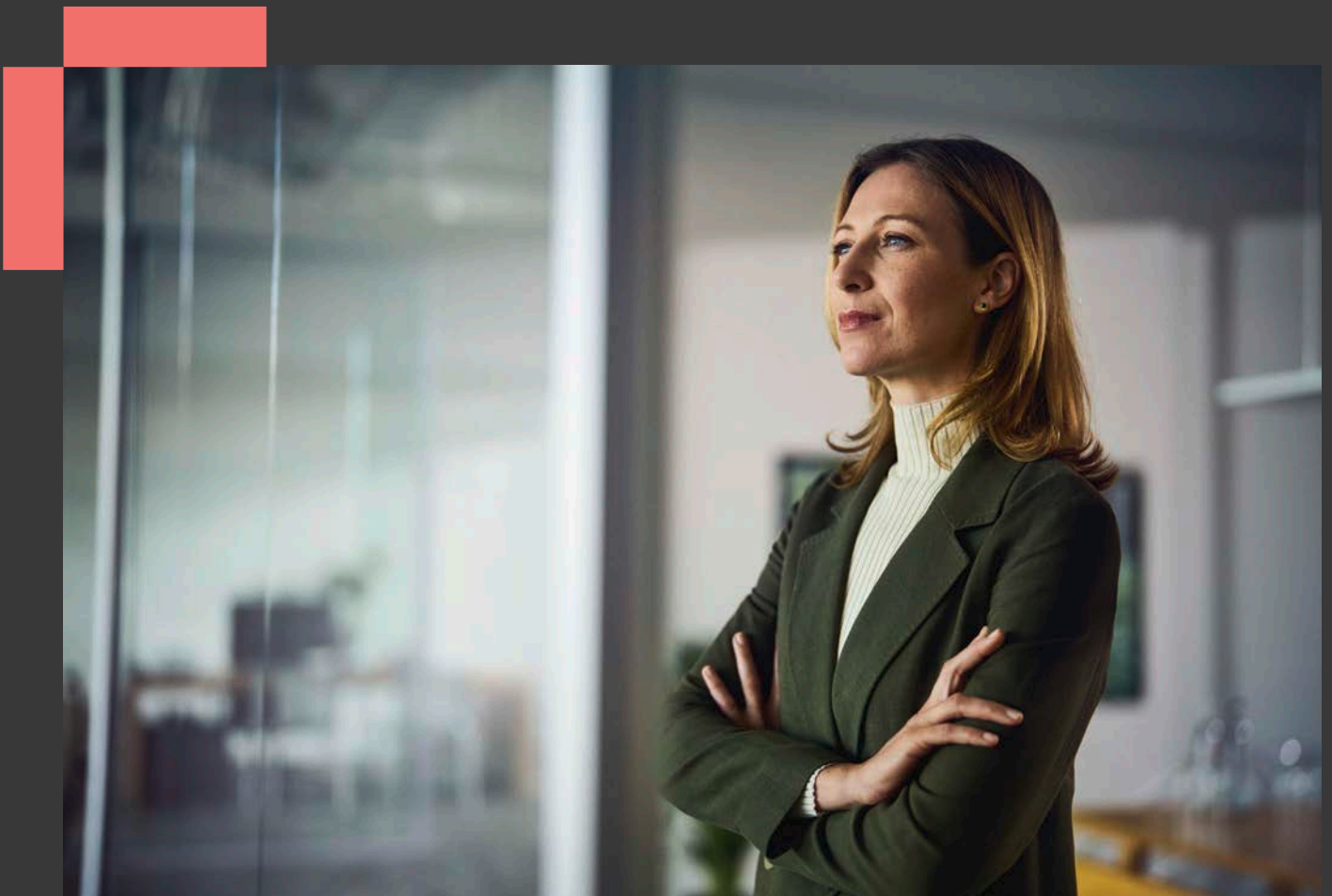

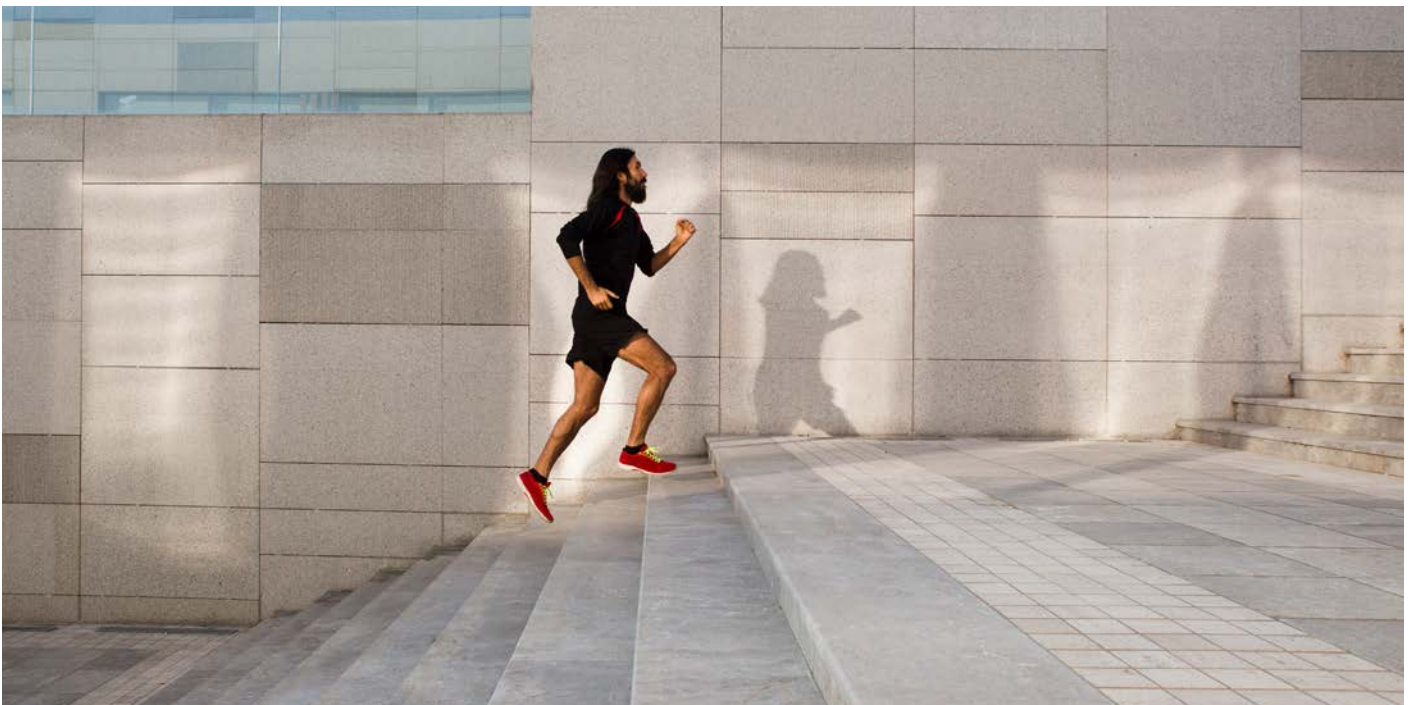

Which challenges merchants typically are facing in regards to subledger accounting

Professional Reconciliation and Accounting

Often done manually and/or with high cost for staff, IT applications and maintenance

Especially if you have multiple legal entities and use multiple currencies, you have to **reconcile your books** with your PSPs statements and the money flow on your bank account

All sales transactions (invoices, credit notes, etc.) but also transactions on your bank account and other subledger activities like write-offs need to find their way into your **general ledger**

Of course this needs to be done in a **highly compliant** way. Nobody needs sleepless nights when it comes to a **month-end closing** or an external or internal audit of closing or finance processes!

A/R Management

High impact on consumer experience, cashflow, bad debts and manual efforts on merchant side

You need a **commercial dunning** process

Whenever customers pay via bank transfer, you need to **match the incoming payment**

In case of under- or overpayments **write-offs** are necessary, dunning fees have to be booked, etc.

If consumers still don't pay, you need to transfer receivables to a **legal collection agency** (CA) – you also need a debt collection provider

Collection agency statements need to be booked, matched and reconciled, write-offs incl. tax-corrections have to be done

Card chargebacks + PayPal disputes need to be partially manual handled and answered

Just integrate your order management / webshop or subscription management system via our simple APIs to send us data like orders or returns.

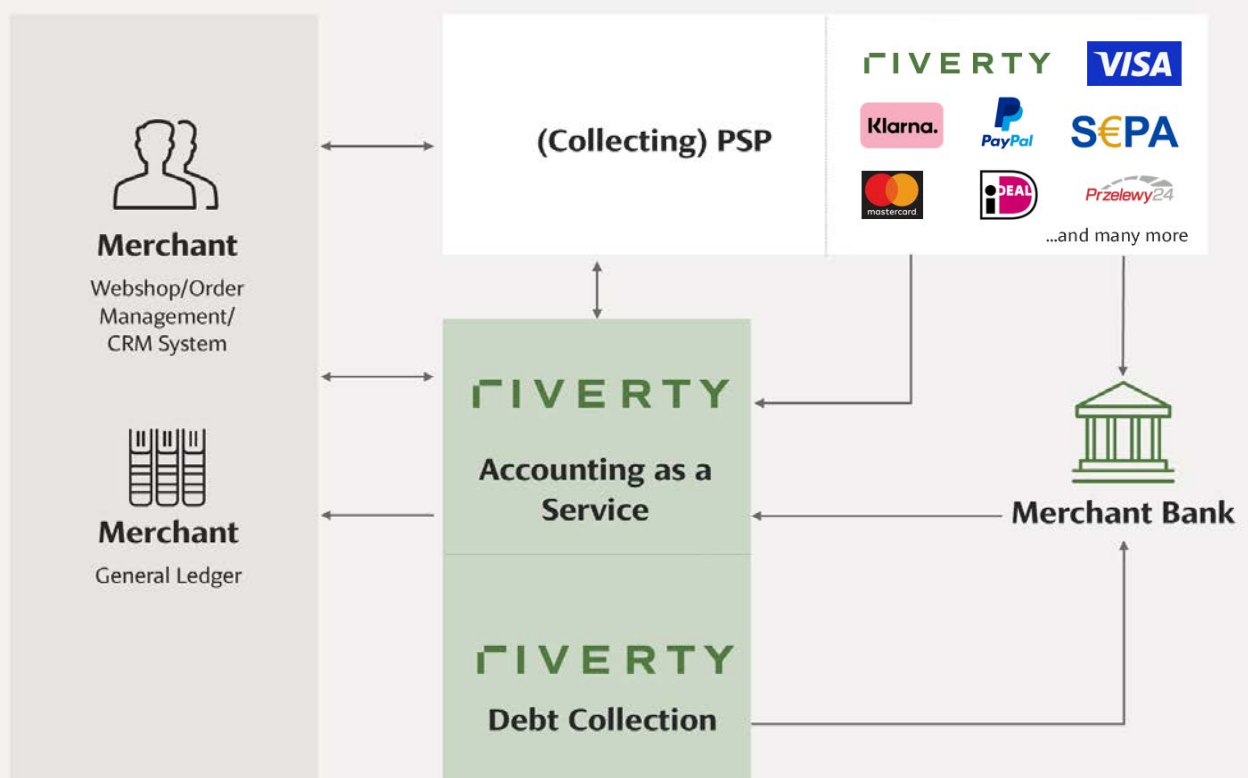
If needed you can easily subscribe to our notifications to listen to multiple events, such as invoice generation or dunning events.

Pricing

Our Pricing is based on three components

Setup

A small one-time fee - this includes setup, training, testing and project efforts, e.g. to connect your bank account to our system

Transactions

Based on the expected volume a price per processed transaction (invoice) will be charged

Manual Exceptions

To ensure our service a fee for every manual exception, e.g. the handling of a non-assignable payment or a ticket request, will be charged

As Collection Agency cost / price positions are regulated by national law and therefore different per country, these are not included yet in this offer. We are happy to provide these on request for specific countries
